The Judges of the Cuyahoga County Court of Common Pleas, Domestic Relations Division make the following findings of fact:

In order to be consistent with the federal and state declarations of emergency due to the Covid-19 pandemic:

The Court's operations continue to be impacted by the need to protect the health of the employees, the community and their respective families, and the need to support the community efforts to control the spread of the virus remains the goal of the Court.

THEREFORE ; IT IS ORDERED:

- 1) All prior orders are incorporated within.
- 2) The Court shall limit all in-person hearings to those of an emergency, i.e. an impossibility to perform remotely, and/or a Domestic Violence proceeding.
- 3) Any contested trial set before a Judge or Magistrate shall proceed within these guidelines. Contact the Judge's office or Magistrate's assigned scheduler noted on the Court's website to obtain further ordered and/or directions.
- 4) All individuals , including Court Judicial Officers and personnel, desiring to enter the courthouse will be subject to available health screening or testing and excluded from admission based upon results of such screening or testing.
- 5) All individuals entering the courthouse must wear a face covering while they are in the courthouse and maintain good hygiene , including hand washing, sanitizing and social distancing.

- 6) All persons seeking entry shall proceed to the Atrium area of the courthouse to communicate with the Court's concierge.
- 7) This order shall stay in effect until further notice from the Court.

This order shall be served upon the Cuyahoga Clerk of Courts, the Cuyahoga Common Pleas General Division, the Cuyahoga County Sheriff and the Cuyahoga County Executive, will be published on the website of the Court and will be provided to media and the CMBA to be disseminated to the local bar.
