

FAQS

- ◆ **Is there a cost to file for a DVCPO?** There is no cost.
- ◆ **How long can a DVCPO last?** A DVCPO remains in force until the date indicated on the Order, with 5 years being the maximum amount of time.
- ◆ **What do I need to bring with me to file for a DVCPO?** You must bring a picture ID, Respondent's full name, date of birth and last known address.
- ◆ **How long does it take to file a DVCPO?** The filing process can take 3-5 hours.
- ◆ **Do I need an attorney to file for a DVCPO?** No, however, the Court highly recommends you obtain legal representation. If you choose to go forward without the assistance of an attorney, you will be held to the same standards as one.
- ◆ **Where can I park?** Parking is in the Huntington Parking Garage, located at the Courthouse, daily rates apply. There is no free parking in or around the Courthouse. There are public lots in the surrounding area.

Legal Words to Know

- ◆ **Advocate** – Person who provides support and resources to a Petitioner during the court process.
- ◆ **Cohabitation** – Living together as spouses but not married.
- ◆ **Continuance** – Delay of a court hearing to another day.
- ◆ **Ex Parte Hearing** – Emergency hearing where only the Petitioner is present.
- ◆ **Full Hearing** – Final hearing where both parties and other witnesses testify, and evidence is offered to the Magistrate who issues a decision.
- ◆ **Magistrate** – Court official who hears the case and issues an Order.
- ◆ **Petition** – Request asking the Court to issue a DVCPO.
- ◆ **Pro Se** – Person who represents him/herself in court without an attorney.
- ◆ **Respondent** – Person against whom claims are made.
- ◆ **Service** – Process of informing a person about the legal action filed against that person.

What is a DVCPO?

A **Domestic Violence Civil Protection Order (DVCPO)** is a court order issued to protect a victim of domestic violence.

What Can a DVCPO do?

A DVCPO can provide the following relief:

- ◆ **Direct the respondent to refrain from abusing, threatening, stalking, harassing or from committing sexually oriented offenses** against the family, household members or person in a dating relationship named as protected.
- ◆ **Grant the Petitioner exclusive rights to reside in the home** and order the Respondent to leave the home.
- ◆ **Temporarily grant parental rights and responsibilities** of minor children, if no other court has determined, or is determining parental rights and responsibilities for the minor children.
- ◆ **Order the Respondent not to enter or be within 500 ft.** of the residence, school, business, or place of employment of the Petitioner, family or household member.
- ◆ **Order removal of the Respondent's weapons** should he/she possess them.

Preparing for Court

- ◆ Be on time.
- ◆ Show up to all hearings.
- ◆ Be prepared to prove your claims. Bring evidence you intend to present to the Court.
- ◆ Review and be familiar with all documents before the hearing.

Court Hearings

There are two hearings involved. Visit the Court's website: domestic.cuyahogacounty.us →Domestic Violence Section for hearings and court processes.

Ex Parte Hearing

- ◆ An emergency hearing where only the Petitioner is present. It is held the same day a Petition for DVCPO is filed.

Full Hearing

- ◆ A final hearing where parties and witnesses can testify, and evidence is offered. The Court can hold a full hearing only after the Respondent has been served with the Petition and/or the *Ex Parte* DVCPO.
