Cuyahoga County Domestic Relations Court Launches Mobile App: CourtConnect

The Cuyahoga County Court of Common Pleas, Domestic Relations Division announced today the launch of **CourtConnect**, a free mobile app designed to connect to litigants and attorneys with Domestic Relations Court. **CourtConnect**, available for iOS and Android devices, provides the public with quick, easy, 24/7 on-the-go access to court-related information through their mobile devices. Some of **CourtConnect's** key features include:

CASE SEARCHES

- Lawyers can log into the app using their e-File account ID and password
- Non-lawyers can register for an account using their valid email address, then flag individual cases to receive push notifications
- Obtain case information including: Parties, Docket, Service and Costs/Billing
- Receive push notifications for:
 - When new documents are filed in your case
 - Hearing dates scheduled
 - Journal Entries filed
 - Cases referred to Mediation or Family Evaluation Services
 - Continuances granted by the Court
- In real time, lawyers can view the status of their cases/case dockets, and review a list of pending cases they are involved in
- Litigants can register for e-filing to view document images from their own cases online

DOMESTIC RELATIONS COURT SERVICES

- Domestic Violence (DV) Department
 - DV information link(s)
 - Frequently asked questions
 - Case management modification

CHILD SUPPORT

- Users can access a link to Ohio Department of Jobs and Family Services (ODJFS) website portal, then access child support payment information
 - At the ODJFS website, users can log in to view status of their child support payments or make child support payments online through Ohio Child Support Payment Central

COURT FEES

- Users can see the court cost information for their case, including their total court costs, current balance due, and billing/payment history
- Users can pay court costs online
